

BUD LIGHT® NFL DRAFT FLYAWAY SWEEPSTAKES - OFFICIAL RULES

1. NO PURCHASE NECESSARY.

2. The “Bud Light NFL Draft Flyaway Sweepstakes” (“Sweepstakes”) is open to residents of the United States who are twenty-one (21) years of age or older at the time of entry. Void where prohibited.

3. Sweepstakes begins at 12:00:00 a.m. Central Daylight Time on September 1, 2018 and ends at 11:59:59 p.m. Central Standard Time on December 31, 2018 (“Sweepstakes Period”).

4. Two (2) Ways to Enter: (a) Internet: Visit <http://draft.absweeps.net> (“Website”) and follow the online instructions to complete and submit an online entry. (b) Text Message: Use your SMS-enabled mobile phone to text “DRAFT” to shortcode 78896 and you will receive information on how to submit an entry. Text message entries will be deemed to have been submitted by the registered owner of the wireless number

used to enter. In the event of a dispute regarding the identity of an online entrant, the authorized subscriber of the email account used to enter will be deemed to be the entrant, and must comply with these rules. The authorized account subscriber is the natural person who is assigned the email address by the ISP or other organization responsible for assigning email addresses. 7. All prizes will be awarded (time permitting). Odds of winning depend on the number of eligible entries received. The potential winners will be notified by phone or email and will be required to respond to the notification within forty-eight (48) hours indicating whether he/she can accept the prize. If no response is received within the time allotted, an alternate potential winner will be randomly selected (time permitting). Any alternate potential winners selected will also be required to respond to the notification within forty-eight (48) hours. Sponsor is not responsible for suspended or discontinued Internet, wireless, or land-line phone service which may result in a potential winner not receiving initial prize notification.
